## To start the process:

1. Complete 3 minute application -- ON REVERSE SIDE.

**Attach most recent four (4) months of VISA/MasterCard statements and fax to the Sales Operations Department at: 877-202-0097**

**We will contact you *within 1 business day* with your pre-approved amount.**

2. Be prepared to fax:
  - Business License
  - 3 minute application
  - Most recent Bank statement
  - Lease or Landlord Agreement
  - Credit Card Processing Statements

## To complete the process:

3. You will have a short conversation with our funding company's Operation/Underwriting Department to answer any questions and provide you with a customized program including:
  - CASH Amount available to you
  - Terms of repayment
  - Amount deducted from your daily Visa/MasterCard receipts.
4. Our team will provide all the forms or documents for your final approval including written quotes. All details are given upfront should you need to consult with your CPA or Attorney
5. The next step will be to gather all your data and documents to complete any other forms sent to you by the Operations/Underwriting Department. Once done, fax back to that department.

## Upon approval:

6. Once you are approved and you have agreed to your customized program you will be asked to assist with funding company with any details on the repayment of the advance through your credit card processor. And in some cases you may choose to change processors to receive a lower processing cost for your traditional credit card processing services.
7. The funding company will wire the money directly into your business checking account for you to use any way you see fit.
8. The funding company will mail you information and contact number and assist in answering any additional questions.
9. You'll receive a monthly statement. OR, with a member password, you will be able to log onto a website to view your payment history, track your daily transactions and see your remaining balance!
